Point B Those who will be coming for interview may take note of following:

- Please read the instructions carefully which are mentioned below and make sure that you are fulfilling the eligibility and you have to carry documents in original to support the same at the time of interview.
- Interview letter of those who have been shortlisted, will be dispatched through speed post on your correspondence address and also intimated on e mail ID, given in your application.
- You should report for interview on scheduled date of your post, even if you have not received interview letter along with all supporting documents in original



➤ You will be allowed to attend interview subject to following:-

Production of the following certificates/documents in original along-with a copy of each, duly self attested:-

- i. Date of Birth; (10th/Matriculation certificate issued by recognized board).
- ii. Caste Certificate (in case of Scheduled Caste/Scheduled Tribe/Other Backward Class)

OBC Candidates: Candidature of all the candidates, apply against OBC category, is PROVISIONAL, subject to production of latest OBC certificate, complying following conditions:

- a) Candidates must produce the valid caste certificate in the format provided by the DoPT vide O.M. No.36036/2/2013-Estt(Res.) dated 30.05.2014 and further clarification issued by DoPT vide OM No.36036/2/2013-Estt(Res-I) dated 31.03.2016.
- b) OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India.
- c) NCL-OBC certificate issued during the period from 01.04.2021 to 31.03.2022 will be considered valid. Candidate who have NCL-OBC certificate issued before or after this period(i.e.01.04.2021 to 31.03.2022) will not be considered valid for this advertisement.
- d) Candidate should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidature will not be considered for OBC post. They will however be treated as UR candidate(if UR posts advertised).

iii. PWBD Certificate

Only such persons would be eligible for reservation under PWBD category who have not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to produce a Disability Certificate as issued by a Competent Authority in prescribed format as per "Rights of Persons with Disabilities Act, 2016", which come into force with effect from 19.04.2017. The candidature of PWBD applicant is subject to evaluation by the Medical Board duly constituted by the Director, AIIMS, New Delhi (This board will evaluate suitability of candidates for the post one is being considered for).

iv. Income and Asset Certificate

- Candidature of candidates under EWS category will be considered subject to submission of Income and Assets certificate in the prescribed format issued by the Competent Authority and subject to verification of genuinity of the certificate by the issuing authority.



- Candidature who fail to produce valid EWS certificate will not be considered for reservation under this category. They will however, be considered as UR candidate.
- The cut off date for income and asset certificate by the candidates is the closing date for online registration for the post i.e. 16.12.2021.

v. **Proof of Educational/Professional qualifications as applicable:**

- MBBS
- MD/MS or equivalent
- DM/M.Ch. or equivalent

- MDS or equivalent

In case of those who are holding DNB in broad specialties or super specialty as qualifying education, they have to produce documentary evidence issued by Competent/Appropriate authority about DNB equivalence with MD/MS/DM/M.Ch/MDS as per NMC New Delhi notification dated 14.02.2022

The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/MCh) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purpose of teaching.

vi. **Expreince Certificate:**

Certificate showing that you have possessed the requisite number of years of teaching and/or research experience on last date of online application i.e.16.12.2021 as prescribed for each post, from MCI/DCI recognized Institution(s) as per the following terms:

- Teaching/Research experience acquired only after post graduate qualification in the specialty will be considered.
- Those who have DNB as qualifying degree will need to have 1 year extra experience i.e. total 4 years from MCI recognized/permitted institution for equivalence if the bed strength of medical institution with attached hospital or hospital granted DNB is less than five hundred (500).
- Teaching experience which will be eligible to be counted for this purpose will be in the concerned specialty from MCI/DCI recognized medical college(in cases where MCI/DCI recognition is from a particular year, experience prior to that will not be considered). Like wise Post Graduate

experience in any institution which awards MCI recognized PG degree in the speciality will only be considered valid.

You are requested to make sure that you have post PG experience which is as per the Recruitment Rules and bring supportive documents(including document from MCI/DCI, if need be) for the same.

- vii. Certificate of registration with Medical Council of India/State Medical Council/Dental council of India/ State Dental Council, as the case may be.
 - viii. **NO OBJECTION CERTIFICATE:** No Objection Certificate from the present employer for your appearance for interview in respect of the post applied for and further indicating that in the event of your appointment, you would be relieved in time for joining the post. If the candidates fail to produce the required NOC from his/her present employer he/she shall not be allowed to appear for interview.
