Result Notification No.31/2023 SECURITY-CUM-FIRE GUARD GRADE-II

(STAGE-I)

On the basis of the Computer Based Test (CBT) (Stage I) held on 27.03.2023, the following is the Roll Number wise list of **Candidates** who have **Provisionally Qualified** for the Physical Standard Test Examination (**Stage-II**) for recruitment to the post of **Security-cum-Fire Guard Grade-II** at AIIMS, New Delhi. The Examination was conducted with reference to the Recruitment Notice No. 1-28/2021-Estt-I(RCT) published in the Newspaper dated 14.11.2022 and the Scheme of Examination uploaded on the website on 14.02.2023.

As per scheme of Examination uploaded on the AIIMS website on 14th February, 2023, the qualifying criteria for **Stage-I** (Online (CBT) Mode Examination) and consequent eligibility for the Physical Standard Test (PST) [**Stage-II**] was as follows:

- **a.** The candidate will have to score a minimum of 50% for UR & EWS, 45% for OBC, 40% for SC and ST categories to qualify in the theory Examination (Stage-I) to be eligible for the Physical Standard Test (PST) [Stage-II].
- b. Only those candidates who have qualified in Stage-I will be called for Stage-II test.
- c. It is mandatory to qualify Stage-II to be shortlisted for Stage-III (PET). (As per Scheme of Examination uploaded on the website on 14.02.2023)
- **d.** Accordingly, on the basis of criteria mentioned in the Scheme of Examination **227 candidates** have qualified in Online (CBT) Examination and are eligible to be called for the Physical Standard Test (PST) [Stage-II].
