It may be noted that candidates will be called for Stage III on the basis of the information provided by them in the online registration form and the results of Stage I & Stage II examinations. No other screening has been performed at this stage with regard to their eligibility and any other relaxation. These will only be determined at time of verification of their Original documents by the Recruitment Cell, AIIMS, New Delhi after declaration of **Stage-III** Examination.

Candidates are hereby informed that they shall appear for the Physical Efficiency Test (PET) at their own risk and peril. AIIMS and CISF shall not be responsible for any consequences including bodily harm, injury or infirmity arising out of the test. Candidates must therefore, satisfy themselves that they are fit to undertake the Physical Efficiency Test (PET) as mentioned in the Scheme of Examination. Candidates who are suffering from any illness or infirmity that may result in any problems during the Physical Efficiency Test must seek appropriate medical advice before appearing for the test.

These results and eligibility are provisional subject to fulfillment of all requirements mentioned in the advertisement and Scheme of Examination. Being eligible at any of the stages is therefore subject to verification of all relevant documents at the end of Stage III, as mentioned above.
