Subject: Information regarding eligibility against chosen set of qualification and attached/provided qualification during registration for Common Recruitment Examination(CRE-2024) -reg.

Attention may be drawn of all the candidates who have applied against any post through CRE-2024, it has come to Institute's notice that many applicants who have applied for multiple group post have not provided the essential educational qualification against chosen set of qualification as required for the specific applied post.

Example

Consider a candidate have applied for any post under Group Post 52. (Junior Scale Steno(Hindi)/Personal Assistant/PA to Principal(S)/Private Secretary/Stenographer/Stenographer Grade-III) having qualification set as follows:

Set 1- 12th class or equivalent qualification from a recognized Board or University

Set 2- Degree from a recognized University

Set 3- Matriculation or its equivalent from a recognized Institute

Case (i) – If any candidate has chosen set 1 only and have provided details of only degree qualifications, then the candidate will be liable for cancellation for his candidature for the applied post based on discrepancies of applied/submitted educational qualification.

Case (ii) – If any candidate has chosen set 2 only and have provided details of degree qualifications, then the candidate will only be considered against the post where degree qualification is required/mentioned. The candidate will not be considered eligible for the posts where Matriculation/12th class or equivalent certificate is required.

Case (iii) – If any candidate has chosen all the set and provides only 10th/ 12th class certificates then, the candidate will only be considered for the posts where 10th/ 12th class educational qualification is mentioned in the essential qualification of Recruitment Rules of respective posts.

Above is for example and same is applicable for all posts.

Considering the above cases, the candidates are informed to provide the correct information against the chosen set of qualification, in cases where candidates chooses all the given sets but does not hold the required qualification it will be a case of misinformation and in this scenario, the institute hold the right for cancellation of the candidature of the candidate against the applied post. Please see Section XIII: LEGAL AND DISCIPLINARY ACTION of advertisement notice.

It is informed that the candidate may kindly provide the correct information against the chosen set. In cases where candidates have chosen set and provided information of himself/herself possessing higher degree/certificate, his candidature for the respective applied post will not be considered and will be rejected on the basis of misinformation.

All candidate will be allowed to edit the information provided against the applied group post during the correction window period i.e. from 12.02.2025 to 14.02.2025 up to 05:00 PM. Any correction after this period may not be entertained and will summarily be rejected without any notice.
